Opening:

Dr. Stefan Maxwell (chair) provided welcome and opening remarks of this meeting of the Governor's Council on Substance Abuse Prevention and Treatment, Pregnant and Parenting Women (PPW) Subcommittee. The meeting was called to order on Tuesday July 22, 2025, and was conducted by Zoom conference. A quorum was present to approve the June 2025 meeting minutes. Janine Breyel made a motion to approve without changes, and Amna Haque seconded. There was no further discussion, and the minutes were approved with all in favor and none opposed. The purpose of the meeting was to provide progress updates on 2025 Key Performance Indicators (KPIs).

Agenda:

In-Person Subcommittee Chair Meeting June 26, 2025

- Dr. Stephen Loyd provided a brief overview of the in-person meeting of the Subcommittee Chairs. The Chairs will meet again today, July 22, 2025 to develop measurable indicators they provide in cross-collaboration of the Recovery Ecosystem Model. Additionally, they will determine priority items for the next legislative session.
- The Subcommittee agreed that there needs to be more cross-Subcommittee meetings for collaboration. They also agreed that they need to work in synergy with the West Virginia First Foundation.
- Dr. Loyd meets with the Governor on Friday, August 1, 2025.

2025 Key Performance Indicator Updates and Quarter 2 Progress Report

- Goal 1, Strategy 1, KPI 1: This KPI was completed in Quarter 1.
- **Goal 1, Strategy 1, KPI 2**: Recommendations are forth coming along with a brief report which will be available on the West Virginia Perinatal Partnership website.
- Goal 1, Strategy 1, KPI 3: No current updates and Kelly Lemon is reaching out to the Maternal

- Risk Advisory Council for a meeting about screening. The group is meeting with the Office of Maternal Child and Family Health at the upcoming 2025 West Virginia Perinatal Summit.
- Goal 1, Strategy 1, KPI 4: The completion of this KPI is dependent on initial meetings with the Maternal Risk Advisory Council which will inform the development of written recommendations to increase screening.
- **Goal 1, Strategy 2, KPI 1:** This is dependent on a meeting with the Housing Workgroup which will occur in Fall 2025.
- Goal 1, Strategy 2, KPI 2: This KPI was completed in Quarter 1.
- Goal 1, Strategy 3, KPI 1: This KPI was completed in Quarter 1.
- Goal 1, Strategy 3, KPI 2: Dr. Maxwell shared video clips from NTI Upstream which have been successful across various social media platforms nationwide. These clips can also be converted to use in doctor's offices and other platforms. The clips highlight the dangers of alcohol use while pregnant. The educational videos can also be used to address dangers of marijuana use while pregnant, which is a highly requested topic given recent prevalence. Health+ Studios has also reached out independently to show interest in producing educational components. Dr. David Didden will reach out to them to share something with the Subcommittee. They can see what exists and determine the next steps. Additionally, the Perinatal Partnership has previously worked with Social Bee Marketing for their social media marketing and recommend them.
