Opening:

Chief Shawn Schwertfeger (Chair) provided welcome and opening remarks of this meeting of the Governor's Council on Substance Abuse Prevention and Treatment, Law Enforcement Subcommittee. The meeting was called to order on Tuesday, July 8, 2025, and was conducted by Zoom conference. A quorum was present to approve the June 10, 2025 meeting minutes. Lata Menon made a motion to approve the minutes, and Errol Randle seconded the motion. Beth Bailey proposed the correction to the June meeting minutes that instead of Sequential Intercept Model (SIM) training, there will be emotional intelligence (EQ) training in Wyoming County in August. There was no further discussion. The motion passed with all in favor, and none opposed. The purpose of this meeting was to discuss the 2025 key performance indicator (KPI) status and progress.

 The Subcommittee introduced themselves for the new attendees, the ODCP Regional Coordinators. Lata Menon is sending all the Regional Coordinators a jot form to capture all the training opportunities available.

2025 KPI Updates and Performance Management Spreadsheet Review and Quarterly Progress Reporting

- **Goal 1, Strategy 1, KPI 1:** The Crisis Intervention Training (CIT) Summit was June 23-June 25, 2025. There were 221 people in attendance with 69 of them being law enforcement.
- **Goal 1, Strategy 1, KPI 2:** Lata Menon is still tracking the county attendance of the June trainings.
- **Goal 2, Strategy 1, KPI 1:** Chief Schwertfeger and Justin Smith gave a presentation on ODMAP at the CIT Summit.

 training that is specific to first responders and provide Mental Health First Aid for Law
 Enforcement and Fire/EMS.
